- To receive up to a \$200 rebate on Home Theater/Home Entertainment Furniture you must simultaneously purchase a select Panasonic VIERA HDTV AND the Home Theater/Home Entertainment Furniture from 8/3/08 through 8/16/08. Both purchases MUST be on the same receipt.
